Mushroom Medicine in Women's Health with Tori Hudson

1. Different species of mushrooms have been shown to be therapeutically beneficial for specific forms of cancer (examples Ganoderma in breast, colon, hepatocellular and prostate cancer. Cordyceps in lung and hepatocellular cancers.)
2. Studies have shown that an active compound in Basidiomycota mushrooms (Active Hexose Correlated Compound or AHCC) has therapeutic benefit in HPV, cervical cancer and chemotherapy-induced toxicity.
3. Trametes (turkey tail mushrooms) studies show positive results in esophageal, lung, stomach, colon and breast cancer.
